## How public is publicly funded theatre?

Based on a research project on the topic of "Cultural Democratisation in Public Theatre", the conference will discuss with international guests how theatres can open up more to a broad and diverse population and how cultural policy can support them in doing so. Perspectives from theatre, research, and cultural policy on publicly funded theatre in England, France and Germany are brought together.

#### The following key questions will be addressed:

- Which cultural policy strategies for equal opportunity to participate in theatre exist in England, France and Germany? What differences can be identified between the three countries?
- How are cultural policy guidelines reflected in the activities of English, French and German theatres with regard to their audiences?
- What are the current findings from audience and audience development research?
